1. WE ARE

The Agency for the Cooperation of Energy Regulators (hereinafter referred to as "the Agency") is a European Union ("EU") body, legally established by Regulation (EC) No 713/2009¹ and operational since 2011. Based in Ljubljana (Slovenia), the Agency is central to the liberalisation of the EU's electricity and natural gas markets.

The purpose of the Agency is to assist National Regulatory Authorities ("NRAs") in exercising, at Union level, the regulatory tasks that they perform in the Member States and, where necessary, to coordinate their action.

In this respect, the Agency:

- a) Complements and coordinates the work of NRAs;
- b) Participates in the development of European network rules;

- Takes, under certain conditions, binding individual decisions on terms and conditions for access and operational security for cross border infrastructure, on cross-border cost allocation for Projects of Common Interest and on terms and conditions or methodologies for the implementation of network codes;
- d) Gives advice on electricity and natural gas related issues to the European institutions;
- e) Monitors the internal markets in electricity and natural gas and reports on its findings;
- f) Monitors trading in wholesale energy products to detect and deter market abuse and ensure the integrity and transparency of EU wholesale energy markets.

The main areas on which the Agency's activities focus are:

- supporting European market integration: this is mainly done through the development of common network and market rules, as well as through the coordination of regional initiatives which are concrete efforts from market participants to work towards greater integration,
- advising the EU Institutions on trans-European energy infrastructure issues: the Agency issues opinions on ten-year network development plans, to ensure that these are in line with priorities set at EU level, and on the draft lists of Projects of Common Interest,
- energy market monitoring: the Agency has a general mission in terms of market monitoring at the EU level and has, since the end of 2011, a very specific responsibility when it comes to the oversight of wholesale energy trading.

The Agency currently employs more than 80 staff and has an approved annual budget of €13.6 million in 2018. The Agency's internal structure comprises five Departments (Electricity, Gas, Market Surveillance and Conduct, Market Integrity and Transparency and Administration) and the Director's Office. The Agency is located in Ljubljana (Slovenia).

2. WE PROPOSE

The Agency is seeking to establish a reserve list for the position of Team Leader - Information Resources Management. The jobholder will be assigned to the Administration Department.

The tasks of the Team Leader - Information Resources Management in the Administration Department will include the following:

- Be responsible for the management and coordination of the Agency's Information Resources Management Team (hereafter "IRM Team"), distribute tasks, roles and responsibilities to the members of the IRM Team, define Key Performance Indicators (KPIs) and priorities for the IRM Team, provide effective leadership, identify training needs and knowledge to be developed within the team;
- Conceive, define, develop and supervise the implementation of the multi annual Information and Communication Technology (hereafter "ICT") strategy, the ICT Policy and the Annual IT work plan, etc.;



- Prepare documentation related to ICT policy and guidelines;
- Be a member and coordinator of the ICT Steering Committee of the Agency (comprising the Director and the Heads of Department), prepare all related work and activities and ensure reporting and follow up by coordinating with the other IT Experts of the Agency;
- Be responsible for the design, implementation and management of the Agency's IT Architecture (considering Enterprise Architecture principles and practices), IT infrastructure and Data center;
- Ensure the efficient management, support, security, maintenance and upgrade of the Agency's ICT systems, servers, virtualised infrastructure, backup systems, monitoring tools, Disaster Recovery Site, service desk, user support, etc.;
- Be responsible for the ICT operations, IT services (based on ITIL practices), and for the development, testing, deployment, maintenance and support of business applications and systems;
- Gather business requirements from across the Agency and, in accordance with the ITC strategy, translate them into ICT solutions/services, reporting and communicating progress and status to the Head of Administration Department and the Director, as appropriate;
- Maintain inter-operability of Agency's ICT systems and applications.
- Estimate, request, monitor and manage the annual budgetary resources allocated to the IRM Team (IT infrastructure, operations, services and IT contracts and projects) and related budget lines;
- Be responsible for the identification of IRM Team's procurement needs (according to EU procurement rules), define terms of reference, draft or ensure appropriate technical specifications for tenders, perform the technical evaluation of the received offers, under the guidance of the Procurement and Contract Management Team, participate in the tender evaluation procedures;
- Manage ICT related contracts, ICT contractors, suppliers and service providers, monitor SLAs, provide reporting to management and internal key stakeholders.

The successful candidate may be required, at times, to assist in other areas of the work of the Agency, according to needs and priorities, as planned and defined by the Head of the Administration Department, or as determined by the Director.

The tasks and the nature of the post may change in the future as a result of any possible reorganisation of the IT-related activities in the Agency.



3. WE LOOK FOR

A) Eligibility criteria

Candidates will be considered eligible for the selection phase on the basis of the following formal criteria to be fulfilled by the deadline for applications:

1. To have a level of education which corresponds to completed university studies of at least four (4) years attested by a diploma;

or

To have a level of education which corresponds to completed university studies attested by a diploma and appropriate professional experience of at least one year when the normal period of university education is at least three (3) years;

(Only study titles that have been awarded in the EU Member States or that are subject to the equivalence certificates issued by the authorities in the said Member States shall be taken into consideration.)

- 2. By the closing date for applications candidates must, after obtaining the qualifications mentioned in point 3.A.1, have acquired at least nine (9) years of professional experience;
- 3. To have a thorough knowledge of one of the official languages of the European Union² and a satisfactory knowledge of a second of these languages (level B2 of CEFR³) to the extent necessary to perform his/her duties;
- 4. To be a national of a Member State of the European Union;
- 5. To be entitled to his or her full rights as a citizen;
- 6. To have fulfilled any obligations imposed by the applicable laws concerning military service;
- 7. To be physically fit to perform the duties linked to the post⁴.

B) Selection criteria

The following criteria will be assessed when selecting the candidates for the interviews:

Technical knowledge:

- 1. University degree in a field relevant to this post, i.e. Information Technology, Computer Science, Electrical Engineering, Physics, Mathematics;
- 2. By the deadline for applications, having acquired at least six (6) years of relevant professional experience⁵ after obtaining the qualifications mentioned in point 3 A) above;
- 3. Knowledge in one or more of the following: Service Management methodologies (such as ITIL), Project Management methodologies (such as PM², Prince 2, PMI, PMBOK, etc.) and IT Governance methodologies (such as COBIT);
- 4. Sound knowledge of project management: management or participation in projects related to software development, IT infrastructure and services, produce relevant artefacts, management of contractors and relevant contracts;
- 5. Good understanding of Enterprise Architecture principles and practices;
- 6. Sound knowledge of Information Security principles and practices (e.g. ISO/IEC 27001);
- 7. Experience in a management role (e.g., management of a team, management of portfolio of projects, or similar).

Communication and other personal skills:

- 1. Very good written and oral command (level C2 of CEFR) of the English language;
- 2. Proven ability to lead a team and work under pressure, combined with capacity to work on several projects simultaneously;
- 3. Excellent analytical capabilities and problem-solving skills;
- 4. Experience of working in an international environment dealing with a very diverse range of stakeholders.

Communication and other personal skills will be assessed at the stage of the oral interview and the written examination.

Candidates are invited briefly to explain in their motivation letter in which positions they acquired their knowledge and professional experience in the specified areas.

4. SELECTION AND APPOINTMENT

A Selection Committee will evaluate the applications and select the candidates meeting the eligibility criteria and best matching the selection criteria.

The Selection Committee will endeavor to invite a minimum of six candidates and a maximum of eight candidates to an interview and written test. However, such numbers may be increased in the case of a larger number of high-scoring candidates participating in the selection procedure or reduced in the case of a limited number of eligible candidates and/or a limited number of high-scoring candidates participating in the selection procedure.

The interview and test will focus on the following aspects:

- Specific competences and knowledge of languages with reference to the selection criteria of the present call for expression of interest;
- General aptitudes to the extent necessary for the performance of the duties in accordance with article 12.2.e of the Conditions of Employment of Other Servants;

A reserve list of the most suitable candidates will be drawn up by the Agency.

In line with Director Decision 2017/16, candidates achieving the qualifying mark in the written test and interview of a minimum of 70% will be placed on the reserve list. The reserve list will be valid until 31/12/2019. Its validity may be extended by decision of the Director.

All candidates will be informed about the outcome of the procedure.

Recruitment will be subject to budgetary availability and assignment of posts by the Budgetary Authority.

5. EQUAL OPPORTUNITIES

The Agency applies an equal opportunities policy and accepts and treats applications without distinction on grounds of sex, race, colour, ethnic or social origin, genetic features, language, religion, political or any other opinion, membership of a national minority, property, birth, disability, age or sexual orientation.

6. CONDITIONS OF EMPLOYMENT

The successful candidate will be appointed by the Director as Temporary Staff in grade AD8, pursuant to Article 2f of the CEOS for a period of 5 years which may be renewed.

Pay and welfare benefits: the pay of staff members consists of a basic salary, allowances and other benefits. Depending on the individual family situation and the place of origin, the successful jobholder may be entitled to: expatriation allowance (16% of the basic salary), household allowance, dependent child allowance, education allowance, pre-school allowance, reimbursement of removal costs, temporary daily subsistence allowance, installation allowance and other benefits. Salaries are exempted from national tax; instead a Union tax at source is paid.

Additional benefits:

- Annual leave entitlement of two days per calendar month plus additional days for age, grade, 2.5 days' home leave, if applicable, and in addition up to 19 ACER holidays per year;
- EU Pension Scheme (after 10 years of service);
- EU Joint Sickness and Insurance Scheme (JSIS), accident and occupational disease coverage, unemployment and invalidity allowance and insurance.

7. DATA PROTECTION

The purpose of processing the data the candidates submit is to manage their application(s) in view of possible preselection and recruitment at the Agency. Personal data is processed by and accessible to authorised Agency's personnel. In some cases, an external expert, equally bound by the same data protection principles, may assist the Agency in the selection of candidates.

The Agency adheres to and is regulated under Regulation (EC) N°45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the European Union institutions and bodies. 8. APPLICATION PROCEDURE

For applications to be valid, candidates must submit (in PDF or Word format):

- a complete and detailed curriculum vitae in English and in European CV format (Europass)⁷
 other formats will not be considered
- a letter of motivation (1-page maximum) in English, explaining in which positions they acquired their knowledge and professional experience in the specified areas identified in Section 2 of this vacancy notice.
- A completed eligibility form

Applications that are not completed are considered as non-valid.

Applications should be sent by email to <u>SELECTIONS-ACER-2018-03@acer.europa.eu</u> quoting the reference number of this call for expression of interest.

Supporting documents (e.g. certified copies of degrees/diplomas, references, proof of experience etc.) should not be sent at this stage but must be submitted at a later stage of the procedure if requested.

In order to facilitate the selection process, all communications to candidates concerning this selection will be in English.

Under no circumstances should candidates approach the Selection Committee, directly or indirectly, concerning this recruitment. The Authority Authorised to Conclude a Contract reserves the right to disqualify any candidate who disregards this instruction.

Applications must be sent by e-mail by 09/09/2018 (23:59 Ljubljana time).

If at any stage in the procedure it is established that any of the information a candidate provided is incorrect, the candidate in question will be disqualified.

9. APPEALS

Pursuant to Article 90(2) of the Staff Regulations of Officials and the Conditions of Employment of Other Servants, a candidate may submit a complaint against an act affecting him/her adversely. The complaint must be lodged within 3 months from the date of notification to the following address:

Should the complaint be rejected, pursuant to Article 270 of the Treaty on the Functioning of the European Union and Article 91 of the Staff Regulations of Officials and the Conditions of Employment of Other Servants, a candidate may request judicial review of the act. Please note also that under Article 2(4) of the General conditions governing the performance of the Ombudsman's duties, any complaint lodged with the European Ombudsman must be preceded by the appropriate administrative approaches to the institutions and bodies concerned.
